- 1. International students must come to the College and get enrolled onto your course before the latest date for registration as stated on your offer letter to comply with student visa restrictions. The College will refuse admission to anybody who arrives later than this date and will inform the UK Visas and Immigration of students failing to enrol by this date.
- **2.** Upon enrolment you must agree and abide by College regulations. These are available to view on the College website and/or upon request. You will also be required to produce original translated (if required) documentary evidence of all prior qualifications and immigration status.
- **3.** The College will use all reasonable endeavours to deliver courses as advertised in the prospectuses, website and by other media. However, in certain circumstances it may be necessary for the College, at short notice, to withdraw certain courses or make variations to the courses offered. Variations or withdrawal may be necessary as a result of lack of demand, lack of key personnel, timetable considerations and change in Government policy, this list is not exhaustive. This information will be passed onto your sponsors and the UK Visas and Immigration and you may lose your right to occupy College arranged Accommodation. You will not be able to return to your studies or receive your award until you have paid all sums due as agreed by the College and subject to compliance with the UK Visas and Immigration regulations.

- **10.** Tuition fees quoted are subject to change in the years following your initial enrolment. Should it be necessary for you to repeat the year or re-sit an exam in a different year, the College reserves the right to apply the rate applicable for new enrolling students in that academic year.
